# Builder Assessments

In addition to the Association dues, Builder members are charged assessments on residential and commercial construction starts and lots, from the onset of membership. This Association’s jurisdiction shall follow and apply, for assessment purpose, to any and all other business entities engaged as general contractor of construction or land development and in which an Association Member is a principal (i.e. has ownership interests or management responsibilities are within the territorial jurisdiction of this Association).

## COLORADO ASSOCIATION OF HOME BUILDERS (CAHB)

A \$20.00 per housing unit assessment will be paid by each Builder to the Colorado Association of Home Builders.

## COLORADO SPRINGS CHAMBER & EDC

HBA Members will additionally be assessed on each building permit pulled from the Pikes Peak Regional Building Department. Upon collection, the assessments (below) will be paid to the Colorado Springs Chamber & EDC for economic development activities. If the Member has made a separate contribution to the Chamber & EDC, these assessments may not apply. Contributions made directly to the Chamber & EDC may be tax deductible; assessments paid to the HBA are not.

### EDC Assessment

**Option A**, \$150 per permit, billed quarterly from the Chamber & EDC Enterprise Tax Zone. A portion of this is tax deductible and the end cost is approximately \$66 per permit pulled.

## HOUSING & BUILDING ASSOCIATION OF COLORADO SPRINGS (HBA)

The assessments outlined below are subject to a \$40,000 annual maximum per member company on lot and builder assessments.

### 1. Single-Family Dwelling Assessment: \$0.025 cents per square foot

Single Family dwelling assessments shall be based on the number of square feet in the dwelling. Determination of square feet per dwelling will be made in accordance with the formula used by Regional Building Department in determining cost of building permits.

### 2. Land Development: \$40.00 per platted lot

Any Member of the Association engaged in the development of land will be assessed according to the filed plat, or if this information is not available, the Member will furnish the information necessary for billing.

### 3. Commercial Unit Assessments

HBA Members will additionally be assessed on each building permit pulled from the Pikes Peak Regional Building Department. Upon collection, the assessments (below) will be paid to the Colorado Springs Chamber & EDC for economic development activities.
